\* Please note: The Foundation receives the after tax amount on all PTO donations.



#### Why is employee participation important?

#### How much of my dollar actually goes to the program or service provided?

To receive a new contribution form, please contact the Foundation Office. If you wish to discontinue payroll deduction, please notify the Mercy Foundation in writing. Changes to your payroll deduction will start in the month following your request.

You can still donate to the Foundation as a contract employee. You can give a donation by cash, check, or set up a monthly donation schedule with your credit card.
